

## Website Terms of Use

**Last Updated on August 31, 2021.**

This Privacy Policy is effective immediately for guests and users sending messages and contact cards through our Site after the date shown above and will become effective for those with preexisting accounts upon their next access to the site.

This Privacy Policy describes our policies on the collection, use, and disclosure of your information in connection with your use of our websites and mobile applications (" **Site**"). The terms "**our**," "**we**," "**us**" refer to ExperienceCare Pharmacy. When you use any of the Sites, you consent to our collection, use, and disclosure of your information as described in this Privacy Policy.

This policy applies to information we collect:

- On any of our Sites.
- In email, text and other electronic messages between you and any of our Sites.
- Through mobile and desktop applications you may download from our Sites or from an app store, which provide dedicated non-browser-based interaction between you and this Site.

This policy does not apply to information collected by:

- Us offline or through any other means, including on any other website operated by Us or any third party.
- Any third party, including through any application or content (including advertising) that may link to or be accessible from or on this Site.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our Sites. By accessing or using our Sites, you agree to this Privacy Policy. This policy may change from time to time, in our sole discretion and your continued use of our Sites after we make changes is deemed to be acceptance of those changes, so please check the policy periodically for updates.

## INFORMATION YOU SUBMIT

We may store the information you submit to or through the Site. We use the information to fulfill your requests, provide Site functionality, improve Site quality, personalize the user experience, provide customer support, message you and comply with legal obligations. Among the information you submit to or through the Site, please note:

1. **Account Registration:** Some of our sites may require you to register. If so, you must provide a valid email address to sign up for an Account on the Site. In addition, you may provide us with your full name, phone number, and address. When you sign up for an account, we opt you in to receive emails and text messages from us by default.
2. **Messaging:** If you exchange messages with others through the Site, we may store these messages to deliver them.

## COOKIES AND OTHER INFORMATION WE COLLECT

In addition to the information, you submit to or through the Site, we also collect and store information from and about you during your use of the Site. We use this information to analyze and track user behavior, personalize your experience, associate it with other information about you, provide the functionality and improve the quality of the Site, and help comply with legal obligations. We collect this information in a few different ways:

1. **Cookies:** We may use cookies, web beacons, local shared objects (sometimes called "flash cookies"), and similar technology in connection with your use of the Site ("Cookies"). Cookies are small data files that may have unique identifiers, and reside, among other places, on your computer or mobile device, in emails we send to you, and on our web pages. Cookies may transmit information about you and your use of the Site, such as your browser type, search preferences, and the date and time of your use. You can disable some (but not all) Cookies in your device or browser settings but doing so may affect your ability to use the Site.
2. **Server Logs:** Our servers log information about your use of the Site, such as your search activity, the pages you view, and the date and time of your visit. Our servers also log information that your computer or mobile device provides to us in connection with your use of the Site, such as your browser type, browser language, IP address, mobile carrier, unique device identifier, location, and requested and referring URLs.

## THIRD PARTIES

We do not rent, share, sell or trade personally identifiable information with third parties for their direct marketing purposes. However, please note the following:

1. **Advertising and Third-Party Cookies:** We may allow third parties who provide services relating to advertising to use Cookies, as defined above, in connection with your

use of the Site. As a result, they may collect and store the same type of information and use it for the same type of purposes as described above, and they may be able to associate

the information they collect with other information they have about you from other sources. We do not necessarily have access to or control over the Cookies they use.

2. **Business Transfers:** We may share information from or about you with subsidiaries, joint ventures, or other companies under common control, in which case we will require them to honor this Privacy Policy. If another company acquires the Site or all or substantially all our assets, that company will possess the same information, and will assume the rights and obligations with respect to that information as described in this Privacy Policy.
3. **Investigations:** We may investigate and disclose information from or about you if we have a good faith belief that such investigation or disclosure is (a) reasonably necessary to comply with legal process and law enforcement instructions and orders, such as a search warrant, subpoena, statute, judicial proceeding, or other legal process served on us; (b) helpful to prevent, investigate, or identify possible wrongdoing in connection with the Site; or (c) protect our rights, reputation, property, or that of our users affiliates, or the public.
4. **Links:** The Site may contain links to unaffiliated third-party websites. Except as set forth herein, we do not share your personal information with them, and are not responsible for their privacy practices. We suggest you read the privacy policies on all such third-party websites.

## CONTROLLING YOUR PERSONAL DATA

Please note that the messages you send or receive using the Site are only private to the extent that you and the sender/recipient keep them private. For example, we do not have any control over whether a recipient of one of your personal messages publicly posts it or its contents.

## CHILDREN

The Site is intended for general audiences and is not directed to children under 18. No one under age 18 may provide any information to or on the Site. We do not knowingly collect personal information from children under 18.
